A. Dates of Contest: The Contest will begin at 12:01am, on October 26, 2009 and end on or about 11:59pm on December 5, 2009. Deadline for registration is 11:59 p.m. on December 5, 2009.

A. One Entry per person per contest day. Valid contest entries must contain all information requested. Incomplete and/or multiple entries will be disqualified.

A. All mail in entries must be received by 5pm on December 4, 2009.

B. One mail in entry per person per contest day.

b. One (1) Grand Prize Winner will be randomly selected from all entries. Grand Prize winner will be announced on or about December 15, 2009.

2. Prize(s). The prize(s) that may be awarded to the eligible winner(s) are (one prize per winner):

A. Grand Prize

a. A trip package for the winner and one (1) guest to a concert of their choice in the city of their choice within the Continental United States. Trip package consists of round-trip airfare for two to selected city; hotel accommodations for three (3) days and two (2) nights; concert

tickets for two (2) (total approximate retail value \$4,000). Prize value may vary depending on departure location and time of travel. Other restrictions and blackout dates may apply. Trip expires on December 31, 2010. All airport, travel taxes and any other incidental expenses associated with the prize are the sole responsibility of winner. Prize provided by Clear Channel. Or cash equivalent may be awarded in the amount of \$4,000.

- b. Winner must provide the company with a minimum of sixty (60) days notice prior to selected date of concert and travel. Winner must provide Company with four (4) alternate concert dates concert dates in case first choice is not available. Restrictions may apply.

All decisions will be made by the Company and are final. The Company may waive any of these rules in its sole discretion.
